For a corporation to be liable for the frauds of its directors, it is not sufficient that they should have known of the fraud. They must have participated therein. And for this purpose, a director is liable to the corporation and to any other person whose rights and interests may have been injuriously affected by the fraud of the director. Ordinarily, the corporation is in no better position than a private individual to sue for the fraud of its directors. It is a separate legal entity with its own rights and liabilities. It is not simply a mere department of the individual directors and may sue as such. However, the individual directors are personally liable for the fraud of the corporation and the corporation is also liable because it was only a creation of the individual directors." In this statement it is manifest that the rule is the same in Illinois as it is in other jurisdictions.
